Dear Men and Women of Moravian:

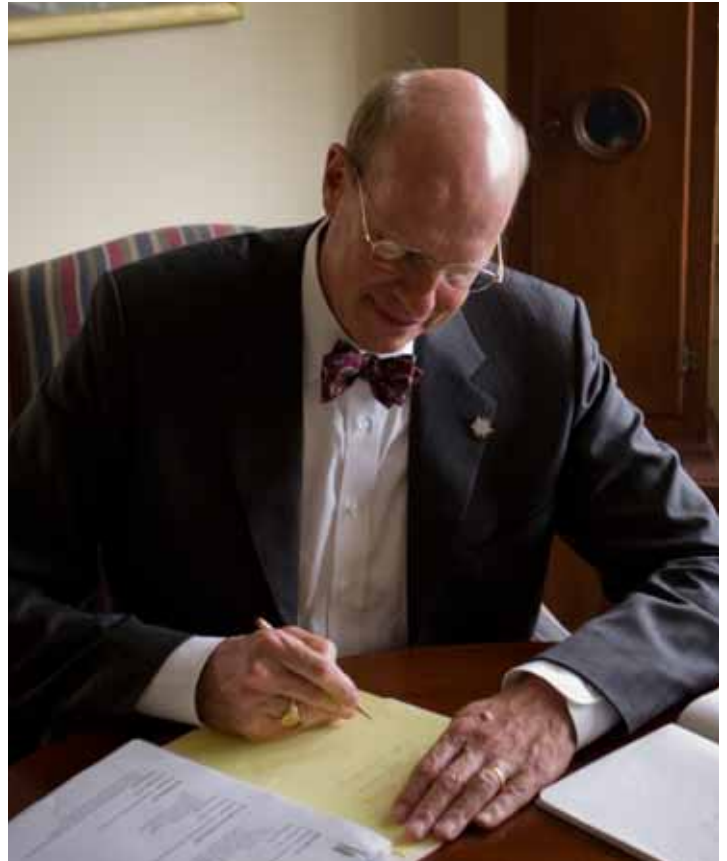
Greetings to you from campus on a beautiful fall day! The foliage is brilliant against a rich blue sky and it is “a great day to be a Hound!”

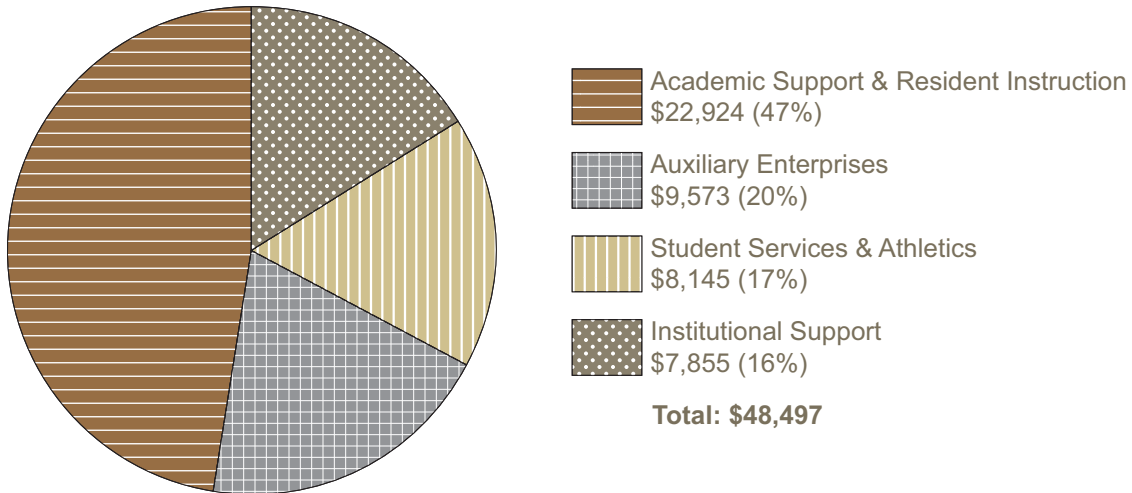

College Finances

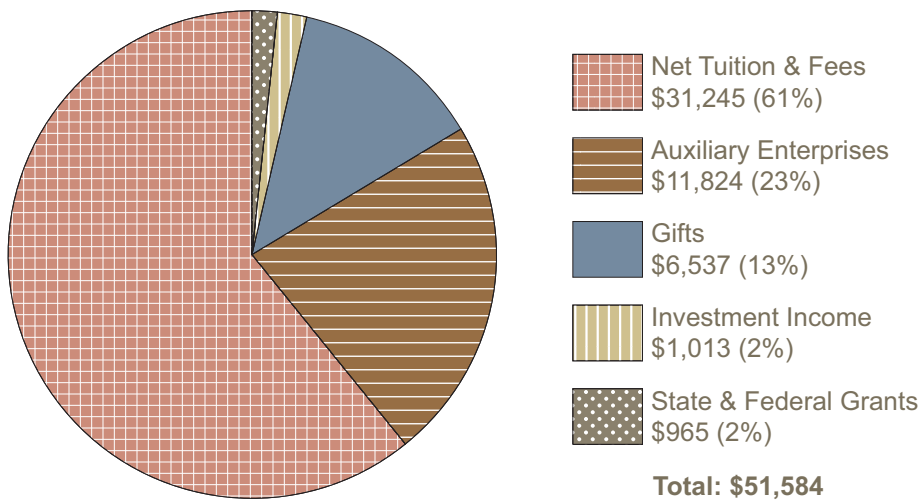
During the 2009-2010 year, the College operating revenues decreased by \$3.0 million (5.5%). Tuition, net of financial aid, and the related auxiliary enterprise revenue decreased by \$1.2 million (2.7%) due to a slight decrease in enrollment coupled with an increase in financial aid. Private gifts and grants decreased from \$8.0 million in 2009 to \$6.5 million in 2010.

College expenditures decreased modestly in all functional categories as a result of planned cost containment efforts. All salaries were frozen and discretionary expenditures were curtailed.

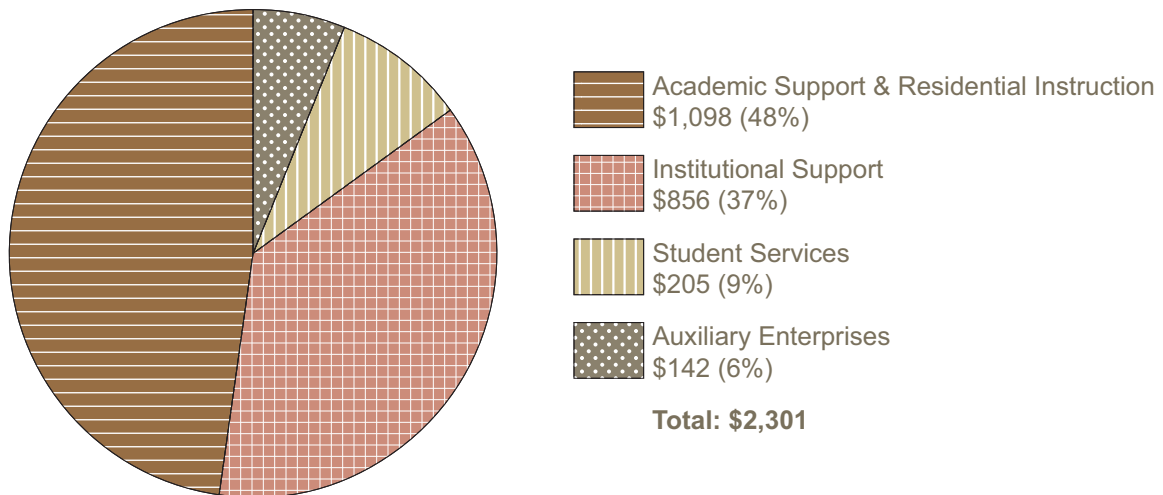

Seminary Finances

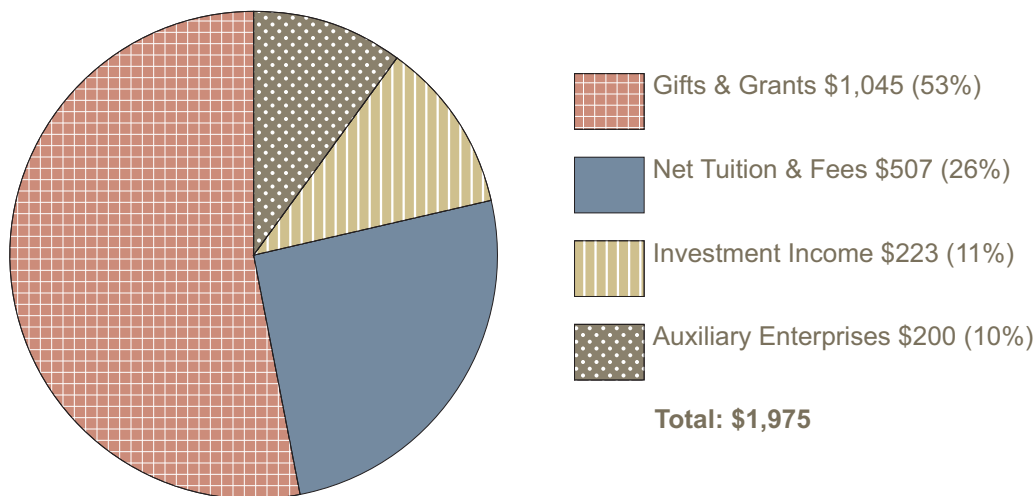
The net assets of the Seminary increased by \$0.9 million in 2009-2010. An increase in net assets from non-operating activity of \$1.2 million was slightly offset by a decrease in net assets from operating activity of \$0.3 million. Total operating revenues of \$2.0 million for 2009-2010 were down \$0.4 million as a result of a decline in private gifts and grants. An \$88,000 increase in net tuition revenue was offset by an \$83,000 decline in investment income.

Operating expenses increased by only \$21,000, or less than 1% of all expenses, reflecting careful fiscal management.

MORAVIAN THEOLOGICAL SEMINARY SOURCES OF REVENUE (IN THOUSANDS) 2009-2010



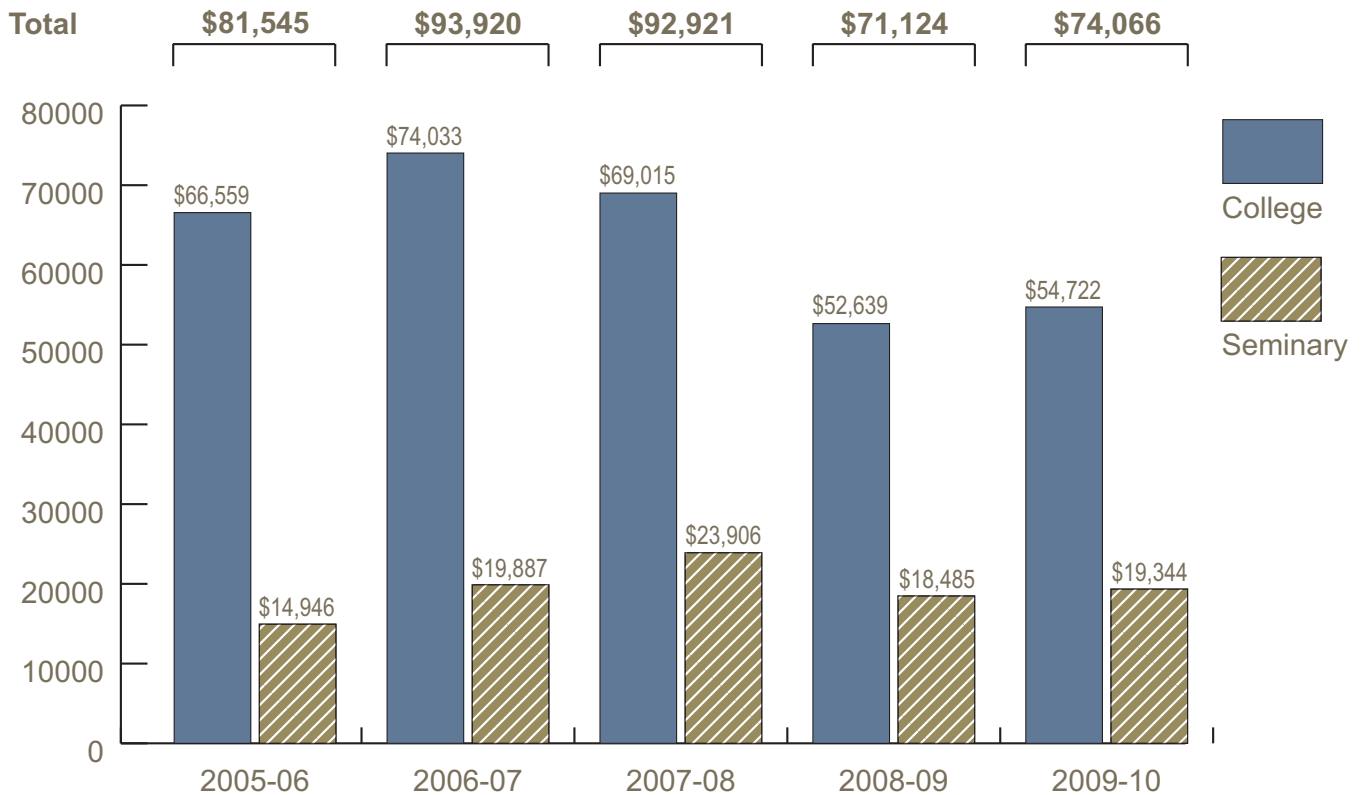

Endowment

The financial markets, while better than in 2009, fluctuated significantly during the year. The total return on investment for the endowment fund for the fiscal year, net of fees, was 7.0%. The target allocations remained stable at 50% growth assets (domestic, international and private equity), 30% risk reduction assets (hedge funds and fixed income) and 20% inflation protection assets (real estate and TIPS). Several manager changes were made which are expected to improve future performance. The market value of the endowment at June 30, 2010 was \$74 million, up from \$71 million in 2009. In fiscal year 2009-2010 the endowment provided \$2.8 million in support for the College operations and \$1.1 million in support for the Seminary operations. The endowment spending rate has been held at 4.5% for the past six years and will be the same for 2010-2011.

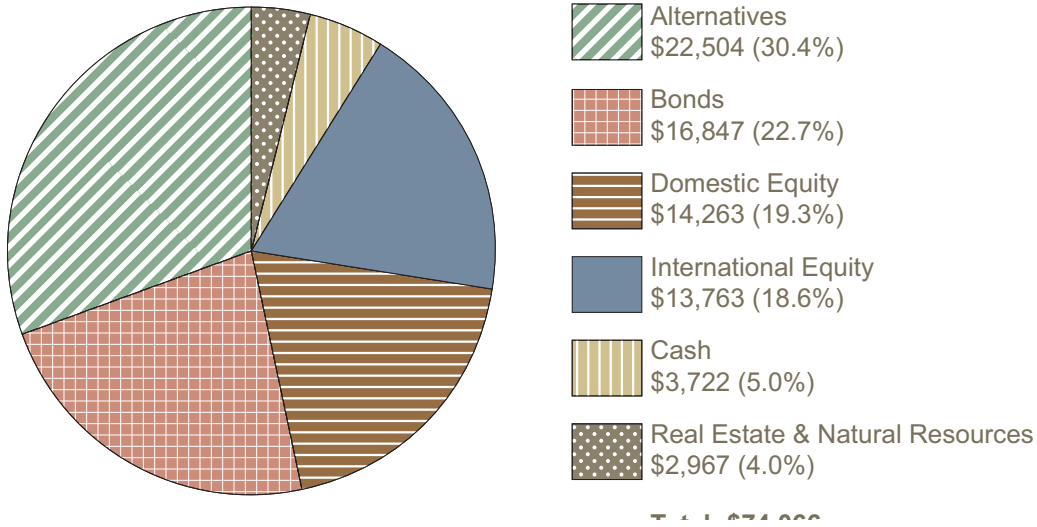

Giving 2009-2010

MORAVIAN COLLEGE HIGHLIGHTS

In 2009-2010 gifts and grants to Moravian College totaled \$5,032,409. We received support from 2,480 alumni. Gifts to the Moravian Fund totaled \$1,079,000. Bequests from alumni and friends accounted for \$646,938 of our total gifts this year.

MORAVIAN THEOLOGICAL SEMINARY HIGHLIGHTS

A total of \$1,081,095 was raised from gifts and grants during the Seminary's 2009-2010 fund year. Of the total, \$372,613 was contributed to the Seminary's Annual Fund. Bequests from alumni and friends of the Seminary totaled \$373,915. The launch of the Seminary's Mission that Matters campaign took place in May. As of June 30, 2010, a total of \$14.7 million has been received in gifts and pledges toward the campaign's goal of \$15 million.
