

## **SUMMARY ANNUAL REPORT**

### **For MORAVIAN UNIVERSITY EMPLOYEE BENEFIT PLAN**

This is a summary of the annual report of the MORAVIAN UNIVERSITY EMPLOYEE BENEFIT PLAN, EIN 24-0795460, Plan No. 502, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

MORAVIAN UNIVERSITY has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

#### **Insurance Information**

The plan has contracts with UNITED CONCORDIA INSURANCE COMPANY, HEARTLAND, INTEGRATED BEHAVIORAL HEALTH, and THE LINCOLN NATIONAL LIFE INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$384,524.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$197,726 and the total of all benefit claims paid under these contracts during the plan year was \$161,432.
