



## Affidavit of Support

### Who is considered an international student?

At Moravian College, an international student is an individual of foreign nationality who will be entering, or has already entered, the United States with a student visa. Students already living in the United States and holding other non-immigrant visas are also considered international students. (Holders of a "B" visa who are in the United States may not apply for admission.)

Even if your current mailing address is in the United States, as an international student, you must provide a valid address outside of the United States.

### Financial Statement of Personal or Family Support

The United States government requires all international applicants to provide proof of ability to pay tuition and living expenses before Kutztown University of Pennsylvania may issue the forms required to obtain a student visa. If you will be relying on personal or family support, you must include, with your application, a financial guarantee letter, stating the sponsor's name and address, and verifying the ability to pay your education-related expenses at Moravian College. The financial statement of personal or family support must either be issued by a bank, or verified by a bank. If your financial support will come from your home government or other official agency (e.g., AMIDEAST), you must submit appropriate documents from your sponsor. (Please refer to the section below for an estimate of the academic year expense.)

Please note: You may submit copies of official financial documents to the Office of International Admissions for the purpose of issuing the I-20. You will be required to take official financial documents to your visa interview.

#### Acceptable evidence of financial support includes:

- Bank statements indicating required currency amounts
- Bank loans for educational purposes
- Scholarship letters
- Investment statements indicating liquid assets
- Government funding

#### Unacceptable financial documents include:

- Chartered accountant statements Payroll reports/expected income Tax statements
- Property assessments
- Credit cards
- Bank statements lacking currency amounts
- Other statements of non-liquid assets

Please be aware that you will not be able to pay for the full amount of your educational expenses by working while you are in the United States. U.S. government regulations strictly limit employment authorization and require that holders of student visas must be full-time students. Therefore, your job opportunities are extremely limited.
