WORKS IN PROGRESS

Original manuscript in progress, Empowering Knowledge: Attending to Differences that Matter (working title)

This book develops my original account of moral attention. This notion builds upon and shares the same name as Iris Murdoch's notion of moral attention, enriching her vision with a robust social justice approach. Murdoch's notion of "a just and loving gaze" as a mode of clear moral perception is compelling, yet I argue this direction is deepened and enriched by the sort of deep self-correction and critical consciousness required in working through such moral challenges as those related to racism.

Original Writing for Project:

"Feminism, Psycho-Social Disabilities, and Voice: Genuine Inclusion in Transformative Theory." This chapter draws on personal narratives of mental health disabilities, unpacking moral insight and growth that can be connected to such experiences.

The four existing essay drafts to (be utilized in the book project) under revision:

"Mindfulness and Critical Consciousness: Cultivating Moral Perception." Here, I unpack "mindfulness" and "critical consciousness" as distinct yet complementary elements of moral attention, or clear moral perception. "Attending to Life: Moral Attention and the Ethics of Bearing Witness." Here, I situate moral attention in the context of testimonies of "bearing witness" – traditions of resistance to oppression.

"Moral Attention: Cultivating Moral Responsiveness From Where We Stand." Here, I focus on "moral attention" as immanent critique. That is, one cannot remove oneself entirely from the particularity of one's perspective, but one can engage in deep critical self-reflection.

"Conflicting Voices, Shared World: Theorizing Differences in Social Location." This essay addresses what Satya P. Mohanty calls multiculturalism as "epistemic cooperation," suggesting that collaborative inquiry across various minoritized identities may be crucial to gaining knowledge.
